1. Apologies: Apologies were received from Coonawara Pétanque Club and Phil O'Reilly

The President declared the meeting open.

### 2. Minutes:

The minutes of the meeting held on the 29 June 2012 had previously been circulated to all members. Ray Beaumont proposed and Glenis Head seconded that they be accepted as a true record of that meeting. The vote accepting them was unanimous. The President and Secretary then signed and dated a copy of the minutes. #### 4. Treasurer's Report:

The outgoing Treasurer presented each delegate with a copy of her Financial Reconciliation report. The report showed the bank balance as \$3807.68 on the 2 August 2012. This included money previously donated to the Junior fund.

The Treasurer moved that the report be accepted. This was seconded by Deb Rodda and carried. The Secretary tabled an expense claim for \$32.80 postage and stationary associated with the AGM data, it was agreed that this should be passed to the new Treasurer and paid.

#### 5. Confirmation of Cheque Signatories.

The constitution requires that three cheque signatories are appointed and any two of the three can authorise cheques. At present the Signatories are Maitie Beaumont, Adrian Clements and Stan Wilson. It was also noted that Graham Clark who passed away in September 2011 was still on the list. It was agreed that Maitie Beaumont and Graham Clark should be removed from the authorised signature list and that Phil O'Reilly the new Treasurer should be added. The Secretary was asked to arrange the necessary forms and pass them on to the Treasurer.

#### 6. Umpire's Report.

Ray reported that the umpires report for Round 1 had been sent to the Secretary. Once again there had been complaints about players smoking on the piste even though the non smoking policy had been announced at the start of the event.

#### 7. Coaches Report

Adrian reported that the Inter State Competition had been set for 17/18 November. The event is for Juniors under 25 years of age and Seniors over 60 years of age. The format require 4 Juniors and 6 Ladies and 6 men for the over 60's. There is a dearth of Junior players in the State also there were insufficient Ladies over 60 that hold National Licences.

Club delegates were asked to enquire in their clubs if any ladies were interested in playing he would approach PFA about upgrading licences as had happened last year. Information should be emailed to Adrian within the week as he hopes to start training on the 11 August.

There was discussion that perhaps we could team up with another State that was having difficulty finding sufficient players

Adrian also reported that Prescott College a private college in Prospect had contacted PFA asking for some Petanque training for its year 7 pupils PFA had sent the request to Adrian who had put the college in touch with the Prospect Petanque Club.

#### 8. Tournament Directors Report

The Tournament Director reported that support for the league rounds appears to have continued into the new season with 24 teams participating in Round 1.

Ray Beaumont asked why the draw which should have been random was not done publicly on the day of the tournament. Anthony replied that the draw was random but he took steps to avoid teams from the same club playing each other as was the common practice at the subsequent rounds.

Analysis of last season's games showed that 113 players participated in the league, 68 in State Championships and 60 in both groups.

#### **9. AOB**

**a.** The Secretary asked for written comments on the draft by laws to enable a vote on the bylaws to be taken at the next meeting.

- d. Glenis Head asked why the practice of presenting medals to the best performing players had stopped. It was unclear why medals had not been presented but it was probably because we have not had a Presentation Dinner for a couple of years. It was decided that medals would be presented to the highest scoring player overall, best player of the other gender, best veteran, best veteran of the other gender best junior and best performed new player based on championship points won in league (interclub) games.
  - Anthony Pietsch was asked to check the scores over the 2011 2012 season.
- e. Stan Wilson asked clubs to send him details of their licenced members for the League records.
