4. Treasurer's Report:

The game scheduling was particularly difficult and the President remarked that the Tournament Director did exceptionally well in view of the difficulties presented on the day.

The Tournament Director reminded the delegates that the next SAPL event is the Interclub Round 4 at his own Club Adelaide Hills which now has a new clubhouse!

9. AOB

There was a wide ranging discussion on the upcoming PFA AGM. Delegates expressed concern about the representation of the State at PFA board level.

Delegates raised concerns about the representation of grass roots petanque players in the Federation.

There was also discussion of the licencing system with a proposal that PFA should look at a general licence.

One club suggested that there should be a Club licence available which would cover a number of members.

Glenis Head stated that she would be at the AGM and would be prepared to act as proxy for any club that could not attend.

The delegates understood that the SAPL Secretary, Stan Wilson would be at the AGM as a PFA Board member.
