An umpires report had been issued for the Singles Championships. There was nothing to report. The TD enquired about his copy of the report, the Secretary apologised as he had not contacted the State Director of Umpiring on this subject. Ray Beaumont suggested that the Secretary passed a copy on to the

#### 6. Coach's Report

Adrian Clements reported 3 of the 4 players representing Australia in the Pan Pacific Championships came from ESP. Sukrit Vaswami, Raja Jamaleddine and Iskender Maski. Deb said that the club had held a successful fund raiser at the Spicy Bites tournament.

Adrian also said that he would start training for the ISC in the near future.

### 7. Tournament Director's Report

The Tournament Director reported that there were 18 Open and 8 Ladies in the State Singles Championships.

Anthony noted that the recent Singles Championships only just broke even due to the cost of the trophies. Deb Rodda proposed that the registration fee should be raised to \$10.00 per player this was seconded by Anthony Pietsch and carried. The Secretary said that he would amend the By Laws to reflect this decision.

### 8. Sixers Competition

The proposal was accepted with the 3 Women and 3 Men option. Two rounds were incorporated into the next seasons calendar, one with club based teams and the other with composite teams.

## 9. Calendar

Tina had prepared a draft Calendar based on inputs from the clubs. Some minor adjustments were made and the Sixers competition inserted.

Allan Sanderson proposed that the club generic opening time be included on the calendar this was agreed.

There were some discussions on the merits of organising a two day competition over one weekend and whether the Coonawara players would be interested in this. Adrian agreed to telephone Mal Redman and ask him.

The committee gave a vote of thanks to Tina for her work on the calendar.

#### 10. PFA

The Secretary had received a new Player Licence Policy from PFA a few hours before the meeting and had circulated it to all clubs. The majority of the delegates had read the new policy and had concerns with the way in which it had been changed particularly with the statements that all members of all clubs would have to be licenced and the withdrawal of the Day Licence facility. Ray Beaumont indicated that all the other States accepted the changes even though SA had not been consulted. He informed the meeting that there was a Board meeting planned for the 29 May and if there were comments to be made they could be presented to the Board then.

Delegates were asked to discuss the policy with their clubs management team and pass any comment in writing to the Secretary by close of play Monday. The Secretary would consolidate them and forward the comments together with a SAPL position to PFA prior to the PFA Board meeting.
