## 7. Tournament Director's Report

The TD reported that since the last meeting Round 1 of the Interclub League had been held with 19 teams participating. He apologized for not having the Stats from R1 available and promised to have them for the next meeting.

Allan Sanderson asked the meeting to note the outstanding quality of result presentation produced by the TD.

#### 8. Webmaster

It would appear that the software that is currently used to maintain the SAPL website is outdated and is complex to use. John Wilson-Smith has been speaking to a relative who is in the business who thought it should be possible to transfer the website content from the current "Dreamweaver" software to "Wordpress" which is available within our current domain Wordpress is apparently much easier to use and will enable multiple users to input data. The Committee asked John Wilson-Smith to continue his enquiries.

Tina Stockley proposed that each affiliated club should contribute cash towards the maintenance of the website by a professional but this option was not pursued.

The Secretary said that we should consider making a proposal to PFA to access the \$250.00 on offer. It was suggested that we should use the money towards the ESP schools evening. The Secretary was asked to contact ESP on the subject.
