Stan Wilson (President) opened the meeting at 1030am thanking all in attendance and ESP for hosting the meeting.

1. Apologies.

2. Minutes of Previous Meeting.

4. Treasurer's Report.

The Treasurer's Report was distributed at the meeting. It is summarised by a slight increase from \$5845 to \$6019 over the period from 16th September 2021 to 20th November 2021. John Wilson-Smith proposed that this report be accepted which was seconded by Terry Hall and unanimously accepted.

JWS proposed that a \$12 registration fee be applied to State titles. Seconded by Tina Stockley, not passed.

Anthony proposed that all League games be \$10 registration, this was seconded by Deb Rodda and the majority were in favour. This new fee will be effective on all SAPL competitions run from the 1st January 2022.

(Post meeting the above is under review – correct procedure not adhered to.)

5. Umpire's Report

The last 2 League events were uneventful and successful.

6. Coach's Report.

Adrian noted that 5 new coaches have completed training and some clinics have been at Prospect and Novar Gardens with good attendances. He would like to see at least one coach at each Club.

PFA Champion Club competition has fallen through. Adrian suggests a Sixer type competition be run to select teams. Have 1 year to sort out.

7. Tournament Director's Report.

Not a lot to report, last 2 competitions were well attended. However, with attendances at League games staying at high levels and possibly increasing, there may be an issue of a shortage of pistes at some clubs. At present AHPC could only accommodate up to 31 teams. SAPL needs to look at a way of getting around this issue – e.g. limit number of teams from each club, (6 suggested), temporary pistes, staggered start times and so on.

8. PFA.

a. State leagues are invited to attend the PFA Zoom meeting to be held early December. Stan is looking for another representative from SAPL to accompany him. We can nominate a subject to discuss at this meeting. Stan suggested and it was decided that clarification of the Insurance policy in particular Public Liability would be our topic of discussion.

9. AOB

- a. The \$1,000 offered by PFA for promotional purposes was discussed and the following suggestions were made and to be instigated. Bumper stickers (Do you have the boules to play Petanque) Most reps liked this, \$300 classified Ad, Intensive on line presence. Terry Hall to complete a Webinar Course, cost \$187 approved.
- b. The forfeit policy was discussed at length. A position was arrived the first game forfeited would be a 13/0 score and games thereafter would be scored as BYES 13/7. Terry Hall to redraft this policy.
- c. The Day License Policy was discussed PFA is leaving accountability for administration to the States. Prospect advised that SAPL cannot change PFA Policy.
- d. A panel of Jurists needs to be appointed. Each club to nominate 2 players/members who are au fait in general with the rules who can be called upon should the need arise. Cannot be an umpire.
- e. TS bought up the COVID topic. SAPL cannot instruct clubs what to do, Clubs should advise their stance on the subject so that future attendees can be informed. At there is no mandate at present 4 clubs are remaining with the Status Quo.

There were no further comments and the meeting was closed at 12.13pm.
