PRESIDENT'S REPORT

Adrian Clements read his report which notes the stand-out influences on SA petanque such as the continuing development of Novar Gardens Petanque club, Eastern Suburbs Petanque clubs new bench mark with interclub championships,

individuals' successes at local interstate and world competition. He thanked the league committee for all their efforts noting valued contribution from Anthony Pietsch and the 17th Australian Masters Games (17AMG) organising committee. TREASURER'S REPORT

The Financial Statement was circulated and presented by John Wilson-Smith. He reported that as of 30th June 2019 a total of \$9642 was available in the account, noting that the large increment was due to receipts from the Australian Masters games (17AMG) which would be distributed back to clubs involved with 17AMG.
